


The item currently printed in tonight's agenda lacked important information related to current committee members and chairs. To avoid confusion, staff has reprinted the entire item with all the information included.

**BACKGROUND AND ANALYSIS**

It is the policy of the City Council that chairpersons and members be selected for the six City Council standing committees and the representatives to other boards, agencies, and committees following a Council election or any other change in Council makeup.

Because there are four separate areas to make appointments, the Council may wish for the appointments to proceed in all four areas, or they may wish to only appoint the City Council committees at tonight's meeting and defer the other appointments until a later time.

**1. Standing Committees**

The City Council adopted the current Council committee structure at the June 20, 1978, City Council meeting. At that meeting, the jurisdiction of the six standing committees, as well as the criteria for selection of the members was established – that being that each Councilmember, other than the Mayor, shall select their chair responsibility in order of seniority. Further, it was decided that the second round selection should be based on reverse order of seniority and the third round would revert back to the original seniority order.

On June 2, 1998, the Finance and Governmental Operations Committee met to review Council seniority issues and discussed possible revisions to the committee selection policy. The Committee voted to make selections based on years of continuous service as a Councilmember and number of votes obtained in the most recent election.

Based on that criteria, current seniority on the Council, excluding the Mayor, is as follows:

## 2. Outside Regional Boards and Agencies

It has been the policy of the City Council that members are appointed by the Mayor to various regional boards and agencies. Some of these organizations require Council action to appoint a voting delegate and an alternate. The representatives hold their appointment for a one-year period, unless otherwise noted. ### 3. Ad Hoc Committees

The ad hoc committees are appointed by the Mayor, and convene for a short period of time. The creation of ad hoc committees was discouraged by the original report on committees, and it was recommended that subjects or issues be assigned to one of the standing committees whenever possible. Where ad hoc committees are created, they should exist only for the life of the assigned subject matter and should not be continually reconstituted.

#### Special Standing Committee

Due to its ongoing status, Council designated the Armed Forces Day Committee as a special standing committee. The most recent members of this committee were:




