
SUBJECT: Calling General Municipal Election for June 3, 2008

ESTIMATED ELECTION COSTS

A cost estimate was received from the Los Angeles County Registrar-Recorder/County Clerk on Friday afternoon after the agenda was posted. They have indicated that the estimated costs of the election at \$198,000 cost for four offices and one measure. Any additional measure added to the ballot would be an additional \$10,000. A change in any of the factors given could impact the actual costs.

Cost estimates for elections include printing, postage, facility rentals, pollworkers and meeting federally mandated language requirements. The printing costs vary with the size of the ballots (number of candidates and issues) and consist of vendor charges for the sample ballot pamphlet printing as well as vote recorder pages with the costs prorated by the number of pages and registered voters. The last invoice for candidate statements was billed at \$851.83 per candidate (10 candidates) for printing a two hundred word statement.
