SUBJECT: General Services – Authorize a purchase order for the acquisition of four (4) 2010 Ford Escape Hybrid Sport Utility Vehicles

Ref: Bid No. B2009-51

Expenditure: \$119,355.20

RECOMMENDATION

Recommendation of the General Services Director that the City Council find the bid from Wondries Chevrolet nonresponsive, find the bid from Wondries Fleet Group nonresponsive, and authorize a purchase order to Power Ford of Torrance, California in the amount of \$119,355.20 including sales tax and tire fees, to furnish four (4) Model Year 2010 Ford Escape Hybrid Sport Utility Vehicles.

Funding

Funding for three of the four vehicles is available from the Fleet Services Vehicle and Equipment Replacement Fund. Funding for the vehicle assigned to Transit is available in the Transit Vehicle Acquisition and Replacement Fund.

BACKGROUND

The proposed vehicle purchases are scheduled replacements for the four (4) vehicles listed below.

Formal Bid Number B2009-51 bid packages were sent to seven (7) prospective dealerships. A total of eight (8) bids were received and opened on December 1, 2009. Power Ford Torrance submitted the lowest responsible bid. Bids received are as follows:




