RECOMMENDATION

The City Clerk recommends that City Council adopt **RESOLUTION 2010-64** declaring the results of the Municipal Election consolidated on the Los Angeles County Primary Election held on June 8, 2010.

The City Clerk is prepared to give the oath of office and to make presentation of Certificates of Election to the duly elected officeholders.

BACKGROUND/ANALYSIS


The City Council on January 26, 2010 (Resolution 2010-07) authorized the City Clerk to request consolidation of the General Municipal Election on the Los Angeles County Primary ballot.

The City Council on March 9, 2010 (Resolution 2010-22) ordered the submission to the voters at the election a measure relating to a change of election date.

The voters selected to four-year terms – Mayor Scotto, Councilmembers Bill Sutherland, Tom Brewer and Cliff Numark, City Clerk Sue Herbers, and City Treasurer Dana Cortez. Measure A related to the change of date for the municipal election did not pass.


A resolution containing the certified copy of the results provided by the Los Angeles County Registrar is attached for your consideration at this time.

RESOLUTION 2010-64**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TORRANCE CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON JUNE 8, 2010 DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW.**

WHEREAS, a General Municipal Election was held and conducted in the City of Torrance, California, on Tuesday, June 8, 2010, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in charter cities; and

WHEREAS, the County Registrar of Voters canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF TORRANCE, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts except vote by mail voter ballots and provisional ballots was 16,568.

That the whole number of vote by mail voter ballots cast in the City was 9,473, making a total of 26,041 ballots cast in the City.

SECTION 2. That the names of persons voted for at the election for Mayor are as follows:

FRANK SCOTTO

That the names of persons voted for at the election for Member of the City Council are as follows:

DICK BROWNING
CLIFF NUMARK

TOM BREWER
BILL SUTHERLAND

That the names of the persons voted for at the election for City Clerk are as follows:
SUE HERBERS

That the names of the persons voted for at the election for City Treasurer are as follows:

STEVE GROOM DANA CORTEZ

That the measure voted upon at the election is as follows:

MEASURE A

Should section 510 of the Charter of the City of Torrance be amended to change the date of holding the general municipal election to the last Tuesday in April of each even numbered year?

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates and for and against the measure were as listed in Exhibit "A" attached.

SECTION 4. The City Council does declare and determine that:

Frank Scotto was elected as **Mayor** for the full term of four years;

Bill Sutherland, Cliff Numark and Tom Brewer were **each** elected as **Members of the City Council** for the full term of four years;

Sue Herbers was elected as **City Clerk** for the full term of four years;

Dana Cortez was elected as **City Treasurer** for the full term of four years.

That as a result of the election, a majority of the voters voting on the measure relating to the change of election date did not vote in favor of it, and that the measure was not carried, and shall not be deemed adopted and ratified.

SECTION 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) The measure voted upon; (4) For what office each person was voted for; (5) The number of votes given at each precinct to each person, and for and against each measure; (6) The total number of votes given to each person, and for and against each measure.

SECTION 6. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 7. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
